 - A. Christopher Thrasher, Student Representative on Presidential Search Committee
 - Has 6 years of SGA experience. The committee has 20 members. They
 began with 80 candidates, then 18 were selected and interviewed, which
 got us to the final 4 candidates.
 - 2. Monday, Tuesday, and Wednesday all candidates will be on campus for open forms for faculty, staff, and students to attend and ask questions. High recommend coming to be voices for the students.
 - 3. Questions:
 - a) Riley: Do you think the committee overall is thinking in the student body or campus as a whole? Thrasher: There are no set requirements but we can have suggested requirements we want in the candidate. Myself wanted someone with a Ph. D with a specific focus on research. All the candidates are different; three have higher educational backgrounds and one does not.
 - b) Collins: Do the faculty and staff support is for more internal or in politics of it? Thrasher: Support for more community but, the staff doesn't have a vote. Faculty, staff, and students only have 6 seats on the committee which is not a huge portion of the committee.
 - c) Hebert: Thank you Chris for coming. Reminder that Chris is our student representative and has done a wonderful voicing on behalf of the students during the search.

- d) Megginson: Gaetz is supposedly running for a congressional seat, if that is true, that would make it difficult being a university president. Is that something the committee is going to take in mind when voting? Thrasher: Has not heard much on that end.
