REVISED NOTICE OF PROPOSED REGULATION AMENDMENT

REGULATION TITLE: UWF/REG-4.008 Tuition and Fees, Fines and Penalties (Fall 2013)

PURPOSE AND EFFECT: The purpose and effect of the regulation is to reflect the amount of tuition, fees, fines and penalties at the University for the 2013-2014 Academic Year.

SUMMARY:

Undergraduate Tuition

The Florida Legislature approved a 3% increase in undergraduate tuition. If this increase is approved by the Governor, the undergraduate tuition will increase from \$103.32 per credit hour to \$106.41 per credit hour. If the tuition is increased, there will be a corresponding percentage increase in the Financial Aid fee and the Technology fee.

Graduate Tuition

A \$16.47 per credit hour increase in the graduate basic tuition and the graduate tuition for cohort courses is proposed. This equates to increases of 6% and 5.2% respectively. There will be a corresponding percentage increase in the Financial Aid fee and the Technology fee.

Other Associated Fees -All Students

A \$2.00 increase in the CITF fee for all students is proposed, which is subject to approval by the Board of Governors. Also proposed are the following increases in the Health, Athletic and Activity and Service fees:

Other Fees

The BOG has increased the third time repeat fee from \$120.24 to \$122.00 per credit hour.
