**PURPOSE AND EFFECT:** The purpose of this amendment is to add the No Credit (NC) grade as an additional grade that is not calculated in the GPA.

**SUMMARY**: The proposed amendment to this regulation is as follows:

- Purpose and definitions were added to comport with approved regulation format
- NC grade was added
- Clarification was added concerning Satisfactory (S) grades
- Information was added concerning the eligibility for and calculation of an NC grade

## I. Purpose:

To enumerate course letter grades, to define additional course grade and transcript symbols, and to explain the computation of grade point averages.

## II. Definitions

"FTIC" means "first time in college." This regulation uses the term as it is defined in UWF/REG-3.001.

## III. Policy

A. The following table represents the numerical equivalents for course letter grades for calculation of a student's grade point average (GPA).

- C. In computation of the required GPA for academic standing and conferral of a degree, the total number of quality points (grade points multiplied by course semester hour credits) is divided by the total number of semester hours for which letter grades are received (per the table in paragraph (1)). All academic requirements tied to a specific letter grade average should be interpreted to mean the numerical average associated with a specific letter grade. Hence, where "C average or better" is required, this is interpreted as "2.0 average or better."
- D. Student teaching, practica, and special courses are graded on a Satisfactory/Unsatisfactory "S/U" basis. "S" grades are equivalent to a "C" average or better.
- E. With the approval of the student's assigned advisor, undergraduate students may take selected courses on a Pass/Fail (P/F) basis. The Pass/Fail option may not be used for any University\_ or departmentally\_required courses.
- F. Course work completed in any student classification (including non-degree) will be included in the student's undergraduate or graduate GPA as determined by the level of the course.
- F.G. For uUndergraduate FTIC students entering Fall 2022 or later, an No Credit "(NC") gGrade will be applied to grades of "D" or "F" in any gGeneral eEducation cCourse taken within one year of their first enrollment date.
  - 1. Determinations of academic standing under UWF/REG-3.008 are based upon the original letter grade (i.e., "D" or "F") rather than the "NC" grade.

- 2. "NC" grades count as attempted hours.
- 3. Repeated courses are ineligible for an "NC" grade.
- 1.4.An "NC" grade will not be applied to a course when the student has been found responsible for violating the Student Code of Academic Conduct (UWF/REG 3.030) in that course.
