# THE UNIVERSITY OF WEST FLORIDA NOTICE OF PROPOSED REGULATION AMENDMENT 

## REGULATION TITLE: UWF/REG-3.001 Admission Standards for First Time In College Student Applicants

SUMMARY: Board of Governors Regulation 6.002, outlining admission standards for students to the State University System, was recently amended. The BOG regulation requires university Boards of Trustees to develop admission regulations consistent with BOG regulations. The proposed amendment to UWF Regulation 3.001 changes UWF admission requirements so that they comport with the BOG's updated academic expectations. In addition, information regarding admission standards for transfer students was removed from UWF Regulation 3.001 and UWF Regulation 3.032 was created so that there would be a separate UWF regulation for transfer student admissions.

## THE FULL TEXT OF THE PROPOSED AMENDMENT TO THIS REGULATION IS SET FORTH BELOW:

Substantial Revision of Regulation 3.001 is proposed. The text below is the proposed new text. The text being replaced follows behind the proposed text.

# University of West Florida Regulation <br> UWF/REG-3.001 Admission Standards for First Time in College Student Applicants 

(1) General Provisions.
a. Admission decisions to the University of West Florida ("UWF" or "University") are made by the University subject to the regulations of the Florida Board of Governors ("BOG").
b. For the purposes of this regulation, "First Time In College" ("FTIC") students are defined as students who have earned a standard high school diploma from a regionally accredited high school or its equivalent and who have earned fewer than 12 semester hours of transferable college credit, as defined in UWF/REG 3.032(12), since graduating from high school, as evaluated by the University of West Florida.
c. Undergraduate admission decisions for FTIC students are determined on a selective basis within curricular, space, enrollment and fiscal limitations. Satisfaction of minimum admission requirements does not guarantee acceptance. The selection process may include, but is not limited to, such factors as grades, test scores, pattern of courses completed, class rank, educational objectives, past conduct, academic recommendations, personal recommendations and achievements. Preference for admission in any term will be given to those applicants whose credentials indicate the greatest promise of academic success while enrolled at UWF. Admission to UWF as a FTIC student affords an applicant the ability to enroll as a degree-seeking candidate in pursuit of a baccalaureate degree.
d. UWF does not discriminate in the admission process based upon age, color, disability, gender (sex or gender identity), marital status, national origin, race, religion, sexual orientation, or veteran status.
(2) First Time In College Student Admission.

The minimum admission requirements expected of FTIC students are established by the Florida Board of Governors and are set forth in BOG Regulation 6.002. Satisfaction of the BOG minimum requirements does not automatically guarantee admission to the University of West Florida. The BOG minimum admission standards require:
a. A standard diploma from a regionally accredited high school or its equivalent. Applicants with a General Educational Development ("GED") certificate or
credential must refer to subparagraph (d). (Students admitted under the Early Admission Program are exempted from this requirement.)
i. For students who entered high school on July 7, 2007, or later, completion of 18 academic units of college-preparatory, year-long courses or equivalents (normally offered in grades nine through 12) are required as follows:
(A) four (4) units of English - three of which must have included substantial writing requirements;
(B) four (4) units of mathematics - at the algebra I level and above;
(C) three (3) units of natural science - two of which must have included substantial laboratory requirements;
(D) three (3) units of social science - history, civics, political science, economics, sociology, psychology or geography;
(E) two (2) units of the same foreign language or American Sign Language demonstrating proficiency through the second level; and
(F) two (2) additional academic elective units from among these five academic areas and other courses approved by the BOG.
ii. For students who entered high school prior to July 7, 2007, completion of 18 academic units of college-preparatory, year-long courses or equivalents (normally offered in grades nine through 12) are required as follows:
(A) four (4) units of English- three of which must have included substantial writing requirements;
(B) three (3) units of mathematics- at the algebra I level and above;
(C) three (3) units of natural science- two of which must have included substantial laboratory requirements;
(D) three (3) units of social science - history, civics, political science, economics, sociology, psychology or geography;
(E) two (2) units of the same foreign language or American Sign Language demonstrating proficiency through the second level; and
(F) three (3) additional academic elective units from among these five academic areas and other courses approved by the BOG.
b. An official standardized test score from either the SAT or ACT; and
c. High school grades that meet either subparagraph i. or ii.:
i. At least a "B" average ( 3.0 on a 4.0 scale) as computed by UWF in the required high school academic units in English, mathematics, natural science, social science, foreign language and academic electives; or
ii. At least a 2.5 to 3.0 grade point average (on a 4.0 scale) as computed by UWF in the required high school academic units in English, mathematics, natural science, social science and foreign language and the following test scores:
(A) $\quad$ SAT - Critical Reading $\geq 460$; or ACT - Reading $\geq 19$
(B) SAT - Mathematics $\geq 460$; or ACT - Mathematics $\geq 19$
(C) $\quad$ SAT - Writing $\geq 440$; or ACT - English/Writing $\geq 18$
d. For applicants with a GED diploma, the following is required:
i. Proof of completion of the GED, including GED test scores
ii. Official transcripts from all high schools attended
iii. Total SAT score of at least 1450 (critical reading, math and writing) or ACT Composite Score of 21

## (3) Enrollment Limitations.

The admission of FTIC students to UWF shall be in accordance with the University's mission and goals and shall comply with any enrollment limitations established by the BOG or the University.
(4) Limited Access Programs.

In addition to the requirements for admission set forth in paragraph two (2) above, applicants seeking admission to limited access programs must meet specific departmental requirements as published in the Undergraduate Catalog. Applicants to a limited access program will receive a decision for general admission to the University of West Florida from the Office of Undergraduate Admission and will receive a separate decision for admission to the limited access program from the department.
(5) Restricted Access Programs.

Some academic programs require a portfolio review, audition, or some element of pre-qualification prior to admission to the program. Explanations of these requirements are published in the Undergraduate Catalog by program. Applicants to a restricted access program will receive a decision for general admission to the University of West Florida from the Office of Undergraduate Admission and will receive a separate decision for admission to the restricted program from the department.
(6) General Application Processing for First Time In College Student Applicants.
a. A complete application for admission, including all required documentation and the non-refundable application fee, must be submitted by all students except those who were previously enrolled at UWF in a degree program.
b. Applications for admission are accepted as early as 12 months before the requested term of entry. Complete applications must be submitted before the published application deadline date for the term desired. UWF reserves the right to return the application and application fee when the application is received after the published deadline or after any enrollment limit is reached for the requested term of entry. UWF also reserves the right to accept applications for admission after the deadline on a space-available basis.
c. Applications for admission are evaluated using a comprehensive review in the Office of Undergraduate Admission. All decisions are communicated in a letter issued to the applicant by the Office of Undergraduate Admissions.
d. Admission to UWF is granted for a specific term and to a specific academic program. Students whose major is undeclared at the time of application will be assigned "undecided" as their academic program choice. The specific term of entry and the academic program to which the student is admitted are both stated in the decision letter.
e. All official transcripts, test scores, and other credentials must be received directly from the issuing institution or agency. Standardized test scores (SAT, ACT, TOEFL, CPT and PERT) may be considered to be official if they are recorded on an official high school transcript. It is the applicant's responsibility to request official copies of all required credentials and to assure their receipt by UWF. All documents and credentials submitted become the property of UWF. The originals will not be returned to applicants nor forwarded to a third party.
f. UWF reserves the right to request validation of an applicant's test scores (SAT, ACT, TOEFL, CPT, or PERT) prior to making an admission decision if deemed necessary.
g. A final high school transcript showing the graduation date must be submitted as soon as issued to confirm the candidate's eligibility to enroll. UWF reserves the right to rescind an applicant's or student's admission to the University if his or her final transcript demonstrates that he or she no longer meets the standards for admission.
h. An application which contains false, fraudulent or incomplete statements may result in denial of admission, denial of further registration, and/or revocation of degree(s) awarded.
i. The University shall evaluate an applicant's previous conduct to determine whether offering the applicant admission is in the best interest of the University. Applicants with a record of previous misconduct at an educational institution or criminal conduct will be evaluated during the admission process in accordance with UWF Regulation 3.003.
j. All FTIC students are required to participate in a New Student Orientation program on the University campus.
k. In accordance with BOG Regulation 6.001(9), and the UWF policy governing immunization requirements, once accepted for admission, each student must submit a signed medical history form and must provide documentation of appropriate immunization.

1. Applicants may request to change their term of entry to a different term. The newly desired term of entry must be within one academic year of the originally requested term of entry provided there is no alternative enrollment at another college or university in the interim. For example, an applicant for the fall 2010 term could change the term of entry to the spring 2011 term or the summer 2011 term but not the fall 2011 term, where one academic year would have elapsed from the original term of entry.
i. $\quad$ All requests for changes of entry dates must be submitted in writing and received before the published application deadline for the new desired term of entry.
ii. A new application and application fee is required for applicants who accumulate additional academic coursework between the original term of entry and the desired term of entry.
iii. A new application and fee is required for applicants who wish to be considered for admission for a term that begins more than 12 months after the originally requested term of entry.
iv. Applicants who request to change their term of entry will be reevaluated for admission using the admissions requirements and selection criteria in effect for the new term requested.
v. Those changing terms of entry who apply to a limited access or restricted program will have their application re-evaluated within the context of the subsequent applicant pool.
(7) Applications and documents submitted by those applicants who are either denied or who do not enroll are retained as inactive files for one year only and are then destroyed.
(8) UWF will provide reasonable substitution of admission requirements for an applicant as long as the absence of the requirement would not constitute a fundamental alteration in the nature of the program of study to which the applicant sought admission, and the applicant establishes:
a. that he or she is disabled as defined in BOG Regulation 6.018, and b. that his or her inability to meet the admission requirement is related to the disability.
(9) FTIC student applicants who do not meet the minimum admissions criteria may be considered for admission to the University of West Florida. Such applicants will be evaluated for admission on a case by case basis using a comprehensive review of factors, such as, but not limited to, a combination of test scores and GPA that indicate potential for success, improvement in high school record, family educational background, socioeconomic status, graduation from a low performing high school, graduating from an International Baccalaureate program, geographic location, military service, special talents or abilities, or other special circumstances that contribute to a diverse student body.
(10) Appeal.

First time in college student applicants denied admission may appeal this decision in writing to the Office of Undergraduate Admission. This request must contain reasons why reconsideration is warranted and should highlight extenuating circumstances and/or appropriate alternative evidence of academic achievement, ability, motivation and responsibility that indicates potential for success at UWF. Student-initiated appeals are heard by the Undergraduate Admission Appeals Committee.
(11) Early Admission.

Early Admission decisions are made as a result of a comprehensive review in the same manner as other FTIC student admission decisions.
(12) Dual Enrollment.

Requirements for permission to participate in the Dual Enrollment Program are outlined in the articulation agreements between UWF and the respective school district.

## University of West Florida Regulation

## UWF/REG-3.001 Undergraduate Admissions and Articulation.

(1) Admission of Freshmen and Sophomores Admission is on a selective basis. Applications must be received no later than thirty days prior to the beginning date of the term; those received after that date will be considered on a space available basis.
(a) Requirements for Admission/Freshmen Students must meet criteria established by the Board of Regents for the State University System. Specific criteria for freshmen are:

1. A diploma from a Florida public or regionally accredited high sehool; a regionally accredited out-of-state high school, or if foreign, its equivalent; or a state approved high school equivalency examination.
2. Scores from the Scholastic Aptitude Test (SAT) of the College Entrance

Examination Board or from the American College Test (ACT).
(b) Freshmen Eligibility Freshmen are eligible for admission in one of three ways:

1. A student who has a satisfactory high sehool record, with a "B" average (3.0-0n a - 4.0 scale) in required high school academic units normally offered in grades 9 through 12 and who submits other appropriate evidence that he/she can be expected to attain successful academic progress in the university is academically eligible for admission. Additional weight will be assigned to grades in Honors/Advanced Placement courses for admissions purposes. Total number of required academic units is 19 . Specific unit requirements are: four units of English, three of which must have included substantial writing requirements; three units of Mathematics at the Algebra I and above level; three units of Natural Science, two of which must have included substantial laboratory requirements; three units of Social Science, i.e., history, civies, political seience, economics, sociology, psychology, or geography; two units of Foreign Language with both credits in the same language; and four additional academic electives from the above five subject areas/courses recommended by the Florida Association of School Administrators, or other groups, and recommended by the Articulation Committee, and approved by the Department of Education and the Board.
2. Students applying for admission who have less than a " $B$ " average in the required academic units described above must present a combination of high school GPA and entry level test scores equivalent to 2.5 on a 4.0 scale in the required academic units, and 900 en combined verbal and quantitative parts of the Scholastic Aptitude Test or a composite score of 19 on the American College Test. Academic eligibility for admission will be determined according to the following Admissions Scale. If the High School GPA in the required academic courses equals any entry in Column I, the SAT/ACT seores must equal or exceed the corresponding entry in Column I.

3. Students applying for admission who do not meet these requirements may be admitted if, in the judgment of the University Admissions Committee, it is determined from appropriate evidence the student can be expected to do successful academic work.
(e) Requirements for Admission/Sophomore-Applicants must meet the requirements for freshmen as outlined; must have completed a comparable freshman program with a grade point average of at least 2.0 on a 4.0 seale; and must be in good standing and eligible to return to the last institution attended without academic probation or suspension.

## 1. Curriculum Requirements (General Education).

a.Students accepted and credited with fewer than 45 semester hours are required to eomplete the lower division core eurrieulum.
b.Students credited with 45 or more semester hours must complete the transfer general education requirements outlined in paragraph five (5).
(d) Requirements for Admission/Juniors and Seniors-Students must qualify under one of the following:

1. Hold the Associate of Arts degree from a Florida public community college. Applications from students who have attended another college after receipt of the A.A. degree will be processed as Transfer Students as outlined in paragraph 3. below.
2. Hold the Associate of Science degree from a Florida public community college with a minimum of 36 semester hours of specified general education courses included in the community college program.
3. Transfer with a minimum of 60 semester hours of acceptable college-level course work including a minimum of 36 semester hours of specified general education courses. Applicants may be admitted with deficiencies in general education courses but should present a minimum of 24 semester hours in required courses. Any deficiencies in general education must be completed prior to graduation from The University of West Florida.
(2) Academic Standing To be considered for admission all applicants must:
(a)-Have maintained an overall average of at least a 2.0 on a 4.0 seale on all college work attempted including all grades for repeated courses.
(b) Be in good standing and eligible to return without academic or diseiplinary
probation to the college-level institution last attended.
(3) Required Documents-All applicants must submit the following:
(a) Application for admission with the nen-refundable $\$ 15$ application fee.
(b) Completed and notarized residence affidavit and supporting documents as required by Section 240.1201, F.S., if entitled to Florida fees.
(e) Official transeripts from each high sehool, ACT or SAT seores (if freshman or sophomore applicant), and transeripts from each college or miversity previously attended. These and other documents such as CLEP scores, DD-295 or DD-214 (when military credit is requested) must be requested in writing by the applicant to be mailed directly to Director of Admissions from the institution/organization concerned. Evaluation of military credits must be requested at the time of original application for degree status.
(4)-Students From Non-Aceredited Institutions-Students from non-aceredited institutions may be considered for admission upon submission of satisfactory scores from the General Examinations of the College-Level Examination Program. Information about this examination may be obtained by writing the College Level Examination Program, Box 1821, Princeten, New Jersey 08540. Students may also be admitted by the University Admissions Committee to validate work from non-aceredited institutions. To validate such work, the student must earn a grade point average of at least 2.00 on the first thirty semester hours attempted at The University of West Florida.
(5) Students Admitted With Deficiencies Students entering with deficiencies in the general education areas must complete such deficiencies prior to graduation. Every student must have completed 36 semester hours of general education courses evenly divided among: English-Humanities; Social Science-History; Science-Mathematics. In the English-Humanities area, at least two courses must be English composition. These courses must meet the requirements of Rule 6A 10.030 , F.A.C. In the sciencemathematics area, two courses must be in mathematics at the level of college algebra or above. Applicants holding the Associate of Arts degree from a Florida public institution will have completed all general education requirements. Courses may be selected from:

(6) Upper Division Students Upper-division students must document at least 60
semester hours of acceptable college-level credits for consideration. (7) University Admissions Committee-Students admitted by special consideration of the University Admissions Committee may be placed on probation.
(a)Appeals-The University Admissions Committee shall meet as necessary to review marginal cases and to consider appeats of admissions decisions by applieants. (b)Procedure Appeal shall be initiated by a letter of request addressed to The University Admissions Committee. (c) Appeal of Committee decisions shall be addressed to the Vice President for Academic Affairs. (8) Credit from NonTraditional Sources - A combined total of 60 semester hours of which not more than 20 semester hours may be upper level credit may be accepted for transfer.
(a) Categories and maximem aceeptable limits are:

(b) Acceptability of Credit Acceptability of credit from all other sources will be determined by the Director of Admissions.
(9)-Recency of Credit Credits which are more than 10 years old may be reviewed and reevaluated for use toward degree requirements at The University of West Florida.
(10)-Level of Transferred Courses-Courses are acceptable for transfer at the level e.g., junior, senior, ete., at which the course was classified by the institution granting the credit. (11)-Choice of Catalog $\Lambda$ student has a choice of meeting the requirements of the eatalog in effect at the time of (1) admission to the University; (2) declaration of a major; or (3) his/her graduation. A student who changes majors has a choice of meeting the requirements of the catalog in effect at the time of (1) said change of major; or (2) his/her graduation. A student who is readmitted to the University after more than one year of non-enrollment has a choice of meeting the requirements of the catalog in effect at the time of (1) readmission; or (2) his/her graduation. The use of a combination of eatalogs to fulfill degree requirements is not permitted.
(12)-Optional Requirements.
(a)-A student holding an Associate of Arts degree with certifieation of the completion of general education requirements from a Florida public junior or community college may elect to complete the degree requirements of The University of West Florida which were in effect at the time the student first entered the junior/community college as a degree-seeking student. The transcript of the student granted this option must demonstrate that a four-year plan was made by the inclusion of the proper lower level courses.
(b)-A Florida public junior/community college graduate who does not enter the University within three years of the date of initial enrollment in the junior/commtnity college as a degree-seeking student forfeits the option to purste degree requirements which were in effect before the initial term of that student's enrollment at the University.
(13) Minimum Grade Required for Transfer Credit.
(a) Students with an Associate of Arts degree transferring to The University of West Florida directly from a Florida public junior or community college which awarded the degree will receive credit for courses completed with a grade of " $D$ " or higher.
(b) Students transferring to The University of West Florida without an Associate of Arts degree, but with an overall grade peint average of 2.0 or higher, will receive credit for all freshman and sophomore courses completed with a grade of " $D$ " or higher. No credit will be allowed for junior or senior level courses completed with a grade of "D". (c) Students accepted for admission with a grade-point average lower than 2.0 by the University Admissions Committee will have courses in which they received a grade of "D" reviewed by this committee. Recommendation concerning the amount of credit to be awarded for courses in which a grade of "D" was received will be made to the chairperson of the department in which the student enrolls. No credit will be allowed for junior or senior level courses completed with a grade of "D".
(14) Provisional Admission - The University may, on a provisional basis, admit a student who, through no fault of his own, has been unable to complete the required admission documents. Only those students who indicate eligibility (based on information submitted by the student) for admission will be accepted provisionally; students must provide all required documents before the deadline, four weeks after the first day of classes of the student's first semester, or be denied further registration as a degree-seeking student.
(15) Required Summer Attendance-All students entering a university in the State University System of Florida with fewer than 60 semester hours of credit will be required to earn at least 9 semester hours of credit prior to graduation by attendance at one or more summer terms in a State University System Institution.
(16) State Assessment Requirements Prior to receiving an associate of atts or a bacealaureate degree, a student must present passing seores on all four subtests of the College Level Academic Skills Test (CLAST). A student who graduated with the
associate of arts degree from a Florida public community/junior college prior to September 1,1982 is exempt from this requirement. $\Lambda$ student who has a specific learning disability such that he cannot demonstrate successful completion of one or more sections of the CLAST and who is achieving in every area except that of the disability, and whose diagnosis indicates that further remediation will not succeed in overeoming the disability, may appeal through the appropriate dean to the CLAST Appeals Committee for consideration. The Committee will, after examining the student's academic and medical records and hearing relevant testimony, grant or deny a waiver for one or more sections of the CLAST. In addition to the CLAST, applicants must complete twelve (12) semester hours of English coursework and six (6) semester hours of mathematics coursework at the level of college algebra or higher, as required by the State Board of Education in Rule 6A-10.030, F.A.C. Students must eomplete these requirements before earning the bacealaureate degree, Students will not be advanced to upper division status until these assessment requirements are met.
(17) Quota Limited Access Programs.
(a) An undergraduate student who is admitted to The University of West Florida and whe wishes to major in special education must present a cumulative grade point average of at least 2.5 on course work completed prior to admission to the University. Students who do not have a 2.5 cumulative grade point average upen admission to the University may request a change of major to the special education program after completing at least 10 semester hours in another major and attaining a grade point average of at least 2.50 om this course work. The request for a change of major will be evaluated by a committee of the department of special education.
(b) Admissions requirements for the B. S. degree program in medical technology include an overall GPA of 2.5 or better; satisfactory completion of lower division prerequisite courses to include general chemistry I \& II, organic chemistry I \& II, botany, zoology, anatomy and physiology (strongly recommended), and college algebra or equivalents; satisfactory completion of junior level prerequisite courses to include geneties, biochemistry I, pathophysiology, general microbiology, applied microbiology, immunology, hematology, and two non-seience electives or equivalents; and completion of the application process to include completion of an application form, a letter of interest, three (3) letters of recommendation, all transeripts, a NAACLS approved transeript evaluation, and a personal interview. Applications must be submitted by February 1; admission decisions are announced April 1.
(18) Cancellation of Admission-Students are admitted to the University only for the term for which they apply. Students who do not enroll in the term for which they have been admitted lose their admission status and must notify the Director of Admissions to change their admission applications for a later term. They will be considered under the policies in effect at that time. Admission is not automatic. If a student has attended another collegiate institution prior to updating the application, the student must provide an official transeript of all course work completed. Specific Authority 240.1201,
