- Open Access (OA) journals are of low quality, are not peerreviewed, and are the equivalent of self-publishing, and thus will be looked down upon by peers
- OA is a pay-to-publish model, so anyone can do it
- OA means giving up all my copyrights in my work

Characteristics of Predatory Journals

- False claims about services provided
- Exploits the need of academics to publish
- Driven by money



- Little regard for quality of work published
- Does not follow accepted scholarly best practices
- Deception to appear legitimate

Impact of Predatory Publishing

- Lack of peer review
- Corrupts the literature
- Work could disappear
- Work is difficult to find in indexes
- Harmful to your reputation

- Email invitation
- Unprofessional website
- Questionable peerreview process
- Rapid publication



- Hidden processing fees
- False indexing claims
- Lack of contact
 - information



- Use of "fake" metrics
- Broad titles and scope
- Unclear policies
- Article submission by email
- Lack of or questionable editorial board


